Motion to compel hearing, Ct indicates defendant will be be getting successor counsel, indicates it would be appropriate to hear this after defendant has obtained new counsel. Defendant does not object to postponement, Ct will hear arguments, but will reserve issue for a later date. Plaintiff argues money had been loaned to defendant, and plaintiff is holder of note - needs bank records to verify alleged payments made, argues to relevance and narrow scope. Defense argues that requests are broad and not relevant - asked for communications going back 20 years, releases for banking institutions for 20 years. Ct questions defendant's position, defense responds. Plaintiff argues it goes to Defendant's credibility, requests order that records for pole building payments should be produced. Ct reiterates concession by defense that if notes are valid, full amount is owed. Plaintiff willing to withdraw motion if that concession is made. Motion to compel is withdrawn.
